Regarding the sexual harassment scandals and other felony counts

**Subject: The Harvey Weinstein of Wall Street**

Here are just a few things which I think will interest you and your newspaper.

The Harvey Weinstein and the Lewis Eisenberg/Goldman Sachs story couldn't have come out thirty years ago but now American attitudes have changed as more women are empowered.

I have the actual lawsuits that Kathy Abraham former administrative assistant to Ambassador Lewis Eisenberg then Sr. Partner at Goldman Sachs filed against him and Goldman Sachs and of course the ones I filed against Goldman Sachs and Lewis Eisenberg and the NYPD. I also have the police transcripts of my administrative hearing where Kathy Abraham testified that Lewis Eisenberg attempted to rape her in her own home and prostitute her to other Goldman Sachs partners.

The whole investigation was squashed. There is much more info.

As a former NYPD Officer I initiated the investigation against Lewis Eisenberg Sr. partner at Goldman Sachs for sexual harassment, sexual misconduct, aggravated harassment, menacing, attempted rape, rape, bribery of an officer, perjury and more. The investigation as per Kathy Abraham's statement was to include prostitution, narcotics and insider trading at Goldman Sachs where Kathy Abraham had in fact knowledge as she was privy to this.

That year a dozen Goldman Sachs partners were forced to resign suddenly which has never happened before after this case exploded in the media then. The real story was never told as Goldman Sachs and Eisenberg's public relations damage control team put a whole different spin on the real events. Over ten women contacted me from Goldman Sachs and later from other Wall Street firms thinking I could help them.

I was under death threats for a while where I had to carry a police radio with me even when I finished my tour of duty so I can access immediate assistance if needed. One attempt was made to run me down with a car near my home.

I will turn all documents over to any serious reporter who would investigate this.

Ambassador Lewis Eisenberg is the Wall Street poster boy for preying on women and the iconic figure for it. I have a photo symbolizing the culture of what was happening at the Goldman Sachs offices where Lewis Eisenberg was celebrating his birthday and he brought in strippers at the office and he was being tied up by one of them dancing around him.

The NYPD and the District Attorney's office had access to Kathy's Abraham's signed sworn statement yet they never investigated it and considered it a personal and business matter. Kathy Abraham and I filed criminal complaints against Lewis Eisenberg. Shortly after several attorneys from Eisenberg and Goldman Sachs came marching in to meet with the District Attorney and everything was dropped. The NYPD later brought me up on administrative charges leading to my dismissal while Eisenberg and Goldman Sachs team tried to have me arrested on extortion charges.

Kathy Abraham later settled her case for what I was told was a half a million dollars but it came from Goldman Sachs not Lewis Eisenberg as he made a deal not to incriminate his company. Kathy Abraham had to sign a statement that there was now never any harassment and that everything was consensual. This left me looking silly. I later sued Kathy Abraham as well over that as it had a negative impact on my case.

I have all the court papers regarding Kathy's suit against Lewis Eisenberg and Goldman Sachs, my suit against them as well and my suit against the NYPD and Kathy Abraham and all their responses. I also have the police interrogation of myself and interview with Lewis Eisenberg. I will make all this available to any serious investigative reporter.

I want to be reinstated with my back pay and pension and to clear my name as well as trying to protect people from the abuses of people in high powered positions in government and in the financial world.

The White House should be renamed the Gold House as they then and even more now hold much of the power in this country.
